## 1. Introduction

- 1.1 MultiSoft has developed a mobile solution for Microsoft Dynamics NAV called MobileNAV.
- 1.2 MultiSoft is an independent, Hungarian owned enterprise and has a valid contract with Microsoft Hungary for the selling and support of the ERP system Microsoft Dynamics NAV (further on referred to as Navision). Based on the above MultiSoft accepts no responsibility whatsoever for any commitments or contracts of Microsoft, of Microsoft Hungary, or for any Partners thereof.

## 2. Subject of the Contract

### 2.1. Components of the MultiSoft MobileNAV solution

- **MobileNAV Add-On:** contains the objects that are necessary on the NAV server side
- **MobileNAV Configuration:** contains the objects (pages and codeunits) as well as additional configuration for the MobileNAV Client App. The configuration controls the client app user interface and behavior.
- **MobileNAV Client App.:** running on hand-held (phone, tablet) hardware
- **MobileNAV Client App. Licence:** the solution has a device-based licensing model, where the customer has to specify the number of devices on which the MobileNAV Client App will run. The Licence is not bound to actual devices, and it is not a concurrent Licence.
- **Published Pages and Configuration:** Available functions and fields described in published NAV pages, and MobileNAV configuration, which contains metadata information about published pages and

codeunit. Basically, the published pages correlate the complexity of the functionality.

- **MobileNAV Page License** – the solution also offers licencing based on functionality. By choosing this model the customer has to specify the number of published NAV pages that they want to use.

Our business model is the following: MultiSoft maintains the MobileNAV Add-on, and the MobileNAV Client app, and the Partner of the End User maintains, customizes the MobileNAV Configuration and Published Pages.

### 3. Validity of the Contract

By installing, having installed, subscribing to, or using the software, you accept this agreement (including any modifications made to them from time to time). If you do not accept this agreement, do not install, have installed, subscribe to, or use the software.

If an individual enters into this agreement on behalf of a legal entity, that individual represents that he or she has the authority to bind that entity to this agreement.

### 4. Definitions

- “you” means the legal entity that has agreed to these license terms and your affiliates;
- “Affiliate” means any legal entity that owns, is owned by, or that is under common ownership with a party;
- “ownership” means more than 50% ownership

## 5. Installation and Use Rights

**MobileNAV Add-On:** You must purchase a MobileNAV Add-On license from your Microsoft Partner to use the MobileNAV. The use rights of this Add-On are defined in the EULA published by Microsoft.

**MobileNAV Client App:** You may only use the client software with the MobileNAV Add-On. You may install an unlimited number of copies of the client software to access your database. The client software may be used only by the number of licensed devices or pages that your license key permits.

**MobileNAV Configuration:** You may use the configuration for unlimited workflows and business areas. You also have the permission to modify the configuration.

MobileNAV Client App reports the usage data to MobileNAV License Server periodically. Make sure that your mobile devices are able to access the following URL:

## 6. Types of licenses

The types of user licenses for the MobileNAV solution are as follows:

**Device CAL:** The End User must acquire and assign a CAL to each device that accesses the MobileNAV solution directly or indirectly. Each device can be used by multiple users.

**Page CAL:** The End User must acquire and assign a Page CAL to each Page that they intend to access. Unlimited number of device is able to connect the database until they connect to Page range described in the Add-On.

## 7. Terms specific to our license model

Your rights to use the software are permanent but may be revoked if you do not comply with the terms of this agreement. Our MobileNAV solution is not entertain the Subscription licensing model.

## 8. Additional Licensing requirements and/or Use Rights

### 8.1 Multiplexing

Multiplexing (sometimes referred to as “pooling”) is a manner of indirect hardware or software access (“indirect access”) that

- pools connections,
- reroutes information,
- reduces the number of users that directly access or use the software, or
- reduces the number of users the software directly manages.

Any user accessing the ERP Solution through a multiplexed connection must be appropriately licensed with a CAL.

### 8.2 Business Process Outsourcing

You **can** use the software to provide business process outsourcing services to your clients or customers. You may make your CALs available to business process outsourcers acting on your behalf and providing services to your business.
